

To get any information you have to follow a simple procedure.

Every Public body has a Public Information Officer (PIO). You may write to him requesting for the information you require. The PIO shall provide you the information within 10 to 20 working days.



What happens if they refuse to give me the information I want?

In case of refusal, you must be given the reasons in writing quoting the section of the Act relied upon for such refusal. Against this decision of the PIO, you have the right to lodge complaint with the Information Commission.

Will I have to pay for the information?



Making an RTI request does not cost anything. It is free of charge.

However, you could be asked to pay for photocopying (first 20 pages are free) or any other charges incurred in providing you the information you sought.

## HOW CAN KP RIGHT TO INFORMATION ACT HELP YOU?

Information is power

Information enables you see exactly what the government is doing.

With information you can, for example

- Ensure that public officials do not overcharge you for a service, once you know what the official fee is;
- Hold contractors to account for local development schemes such as roads and waterworks etc. Once you know what work they were paid to carry out, you can demand this is done fully and properly.
- Find out what happened to your application for a government job and if you didn't get it, why were you rejected and someone else was selected. Once you know what the criteria was for selection and how many marks each candidate secured. You will know if the selection process was transparent;
- Push for better services and facilities budgeted for by the Government in your area e.g. schools, health facilities etc.



We all need to know and future.



What is RTI all about?

The RTI Act is there to:

- Protect our Constitutional Right to access Information:
- Enhance transparency, accountability and effectiveness of the Government.



You may request for information from any public body at provincial and local level e.g. Department of health & education, municipalities, universities and schools etc.

**PUBLIC BODIES ARE OBLIGED** TO PROVIDE INFORMATION YOU SEEK WITH SOME EXEMPTIONS



Yes, you can ask for any information, although access to certain information may be refused as Public bodies are exempted from providing:

- Personal or commercial information about a third party;
- Financial, technical or scientific information about a third party;
- Information which may affect Court or Police proceedings.

However, if the disclosure would dig out any corruption or wrongdoing, it shall be provided even if exempted.
