The case was discussed in detail with the representative of the Public Body. This case is regarding the issue of Miss Mehtab Shaheen retiring in April, 2013 and requesting for pension since then. As per the statement of the PIO, the Service book of the lady was reportedly lost at same stage after her retirement where upon her case could not be processed. An inquiry had been ordered by the DHO but the doctor to whom the job was assigned, did not complete the inquiry and was posted out, thereafter, another doctor was given a job of the said inquiry. He submitted his inquiry report to the DHO on the basis of which a new duplicate service book has been prepared and the case for pension of the lady has since been sent to the AG office which is in process.

It is rather shameful on the part of the DHO office who are responsible for not being able to arrange pension for the lady in over three years. The DHO is advised to comply with the directions of the Supreme Court Order contained in PLD 2007 Supreme Court 35 under which the Supreme Court has categorically mentioned that "Government servants after having served for a considerably long period during which they gave their blood and sweat to the department had to die in a miserable condition on account of non-payment of pension/pensionary benefits etc. Responsibility could be fixed upon the persons who were directly responsible for the same but at the same time it was an overall problem almost in every department, where public functionaries failed to play their due role in accordance with law, resultantly good governance was suffering badly".

Further, the DHO is also directed to personally ensure the implementation of the Supreme Court's directions to all Provincial Government as well as to Accountant General Office "for strict adherence to pension rules and to clear such cases within a period of not more than two weeks without fail". The DHO will send implementation report to this Commission within **fourteen** days from today.



The Department, feeling that it would be providing certain information which could be considered as secret by the Firms, wrote to them (Annexure 'A') requesting for their consent to provide the documents. Two firms "Asia Trading Company" and "Mehran Enterprises" informed (Annexure 'B' & 'C') that they would not like the information provided to the requesters as it contains bank statements and financial data etc. which if provided to a third party would jeopardize the commercial interests of the firms. The contention of the firm is taken into account but it is not agreed with as the documents on the basis of which firms qualifications have been submitted in the office are no longer secret documents but a matter of public record.

The PIO informed that the complainant Mr. Muhammad Noman Khan's firm (Farhan Enterprises) had been blacklisted in July, 2012 (Annexure 'D'). This is a strange situation because the Directorate would know the reason as to why a blacklisted firm was allowed to compete. The Directorate should hold on enquiry in this matter and fix responsibility under intimation to this Commission. As for the documents regarding the seven qualified firms and the criteria for the qualification is concerned, the same must be provided to the complainant within seven days of the receipt of these Proceedings failing which punitive action will be taken under the law.






