

For the remaining information, the complainant lodged a complaint with the Right to Information Commission. The complaint came up for hearing on 03rd September, 2015 wherein the PIO was directed to provide the remaining information duly attested to the complainant by 07th September, 2015.

The complainant sent an e-mail on 09th Sept., 2015 to the PIO of the University requesting that date, time and place be indicated so that he could come and collect the remaining information duly attested. The PIO did not respond to the e-mail of the complainant.

It has been observed that the callous and uncalled for attitude, adopted by the PIO's of Abdul Wali Khan University, reflects very poorly on the Public Body as for the supply of information to the complainants/requesters is concerned.

Today, too, the representative of the Public Body has brought no documents/information to this Commission. He has informed that the newly appointed PIO is busy preparing for an examination to be held on 16th September, 2015 and told him (representative) to inform the officials of the Commission that the complainant may visit his office after that date to collect his information. It may be mentioned here that the Assistant Registrar of Right to Information Commission had informed the PIO to ensure his attendance on 13th Oct., 2015 but he failed to do so.

The complainant had lodged his complaint with the RTIC on 5th July, 2015 and the RTIC had very categorically asked the PIO of the Public Body to provide the information to the complainant vide RTIC dated: 24th July, 2015, Proceedings Order dated: 03rd September, 2015 and another letter dated: 18th September, 2015 but all to no avail.

As all avenues have been exhausted without the University Authorities taking notice, hence a show Cause Notice be issued to the PIO of the Public Body.

This is the oldest case pending before this Commission, the complaint having being received in the RTIC on 23rd February, 2015. The PIO of the Abdul Wali Khan University was, vide RTIC letter dated: 25th February, 2015, asked to ensure that the information sought by the complainant be provided to the complainant within ten days. This was not complied with as is evident from the complaint received in the RTIC on 19th March, 2015.

In the first Proceedings in this complaint held on 18th March, 2015, the Registrar and Assistant Registrar of the University were both present and pleaded their case but the matter was clarified to them and they were directed to ensure that the information sought is provided to the complainant. As the Order was not complied with, the Registrar was addressed on 04th May, 2015 to do the needful.

During the Proceedings held on 11th May, 2015, the Orders were repeated to which the PIO agreed to provide the information by 15th May, 2015. As no confirmation was received from the Public Body, they were again asked to confirm in writing or explain as to why the information was not provided. In response, the PIO of Abdul Wali Khan University vide his letter dated: 15th June, 2015 informed the RTIC that the information had been provided but the complainant informed that it was not so and hence Proceedings were again held on 15th July, 2015 in which a show cause notice was to be issued to Mr. Muhammad Tariq, Additional Registrar and Mr. Hassan Khan, Assistant Registrar but they once again requested to be given time to furnish the information. In subsequent Proceedings held on 03rd September, 2015 same directions were issued but to no avail.

The above brief background is an indication enough that the Authorities of the Public Body are neither interested in providing the information nor ensuring that the provisions of the Act are complied with. This being the case, a show cause notice be issued to the Registrar of the Abdul Wali Khan University to show cause as to why action should not be taken against him under the Law.
