



It is a matter of concern that the Government has built Water Tank over the land but had not transferred it in the name of the Government which is bound to create legal problems in the future. It would have been in the fitness of things if the land had been legally transferred in the name of the Government. A copy of these Proceedings will be sent to the Secretary, Public Health Engineering Department, Peshawar for reviewing the policy in this regard. Hence, this case is closed.


