



Background of the case is that a citizen namely Talat Mehmood S/O Shams Ur Rahman filed an information request on 22/05/2017, before the A.D LG for seeking information from the village/neighborhood Council Doda khel, District Karak for knowing the details of development as well as non-development funds allocated to the Village Council Doda Khel in 2015-16.

The A.D LG directed the Nazim Village Council to provide the required information. The Nazim however refused to do so and instead stated that information relating to only Marriages, death and divorces cases could be given to him and nothing else. Feeling aggrieved with this order he filed a complaint before the Commission on 31-01-2018.

Consequently, the Secretary Village Council was summoned who appeared before the Commission today. During the proceedings, the Secretary Village Council deposed that he had explained to the Nazim that under the RTI Act 2013, every citizen was entitled to receive information of public importance, however he was restrained to do so by the Nazim. During the proceedings the complainant deposed that the Nazim had put pressure on him to withdraw his information request, and also threatened him with dire consequences if he insisted on receiving information about the funds of the concerned Village Council.

In view of the facts mentioned above it becomes evident that the Nazim Village Council Doda Khel deliberately obstructed the provision of information to a citizen which was his constitutional right. The Commission However directed the Secretary Village Council to provide the requisite
