The website did not contain the remaining information i.e. the expenditures incurred on the visits abroad of the Speaker & other officers between the periods from **June, 2013** to **July, 2017**.
2. It was therefore decided that expenditure incurred on the visits abroad, should be provided to the complainant within **07** days of issuance of this order, with intimation to this Commission. This is the last chance given to the PIO, failing which penalty shall be imposed under section 26(3)(b) of the RTI Act, 2013 for persistently delaying the provision of complete information to a citizen.




