**Memorandum of Understanding**

Whereas the Khyber Pakhtunkhwa Information Commission has the objective to ensure the access of citizens to information in government departments to create a transparent and corruption-free Environment conducive for the growth of democracy.

As enshrined in the Article 19A of the Constitution of Pakistan 1973 states that, the RTI enables the public and civil societies to access information held by public bodies and empowers them to hold their leaders accountable and ensure respect and observance of the human rights.

- e. Developing Coordination with other NGOs/ Community based organizations to support the efforts.
- f. Financial requirements (if any) will be met by Da Hawwa Lur
