Accordingly a summon was issued on **24-07-2018** to the AD LG&RDD, Peshawar to attend the Commission along with the record. The Assistant

In view of the above it becomes abundantly clear that a citizen is persistently being  
denied access to information without any cogent reason. It was therefore decided  
to issue a show cause notice to the PIO.
