In the light of this explanation, it is to be noted that the University has not correctly interpreted the request. The University is directed to give information regarding money spent on Hotels-Restaurants and Laundry, if any. If no expenditure has been incurred on these items, then a nil reply shall be given.

Later on, this Commission has written a letter on 16th March, 2015 in detail to Assistant Director (Admn), IG Prison, Peshawar refuting the stand taken by the Prison Department and issued a direction to give information within five days. The PIO of IG Prison Department, Peshawar is still not committing to provide the information since the Home Department/Administrative Department has regretted the supply of information. It was brought to the notice of PIO that no PIO is duty bound to seek approval of higher authority before the delivery of any information under Right to Information Act, 2013. The PIO of IG Prison Department, Peshawar undertakes to solve this matter within ten working days and will inform this Commission failing which the punitive clauses of the RTI Act, 2013 would be resorted to.
