In this case the complainant had sought information regarding appointment letter, complete educational certificates and promotion orders in respect of Mr. Muhammad Arif presently working as Naib Tehsildar. Mr. Mehboob ur Rehman had brought matriculation certificate, a photocopy from the service book, order of SMBR dated: 18-03-2010, order of appointment of Mr. Muhammad Arif as Patwari on temporary basis dated: 08-12-1994, his promotion order as Qanoongo dated: 06-04-2001 and his promotion order as Naib Tehsildar in his own pay scale dated: 19-04-2010 alongwith the order of SMBR dated: 18-03-2010 through which the Department has accepted his appeal for appointment as Naib Tehsildar. It was the contention of the complainant that the service book of the said Patwari/Naib Tehsildar is missing from the record. In this connection, he produced a copy of letter written by Additional Deputy Commissioner, Karak dated: 16-01-2015 in which Mr. Muhammad Arif was directed to return his service book to the office. Mr. Mehmood ur Rehman was provided opportunity to contact his office by telephone to verify the availability of this service book in the office of DC, Karak, where after he informed that the service book is not available in the office. Since the service book is not available, therefore, copies from the same service book as requested by the complainant cannot be provided to him.

The complainant is seeking the following documents:

1. Order of the Commissioner, Kohat dated: 08-05-1995 through which the order of appointment of the said Patwari was set aside.
2. Attested copy of the order of Revenue Minister reinstating him in service.
3. To confirm the availability of the order of Peshawar High Court in CR No. 679 of 1995 decided on 20-11-1996 whereby the order of Revenue Minister was set aside.
4. Attested copy of BA degree obtained by the said Mr. Muhammad Arif.
5. Seniority list showing the name of Mr. Muhammad Arif from his date of appointment till date.
6. Letter by SMBR office containing direction to restrict the inquiry in respect of car only.
7. Copy of the affidavit filed by Mr. Mehmood available in inquiry file.
8. Attested copy of the statement given by Mr. Mehmood in the said inquiry Proceedings.






### Proceedings

Complainant Mr. Shoaib Zaman is not in attendance. Prof. Ikram Ullah, Controller, Mr. Bashir Ahmad, Public Relation Officer/PIO, & Mr. Inam Ullah, Additional Registrar, University of Science & Technology, Bannu are present.

The issue of giving the answer sheet/script to the complainant in the subject of General Equilibrium & Welfare Economics was discussed in detail. The Controller of UST, Bannu referred the Supreme Court decision of 1996 SCMR 676 and said that the copy of the answer books cannot be provided to the candidates. Perusal of the said judgment shows that in that case/Writ Petition, the High Court had summoned all the answer books to the court to evaluate whether examiners had carried out marking of numbers correctly or not. The Honorable Supreme Court held that marking of numbers on answer books, being a technical job performed by the experts, High Court was not expected to undertake the same and exercise all his powers under Article 191 of the Constitution.

We, in the present Proceedings, are asking for a copy of the answer sheet to the candidate as he is not satisfied with the marking of his paper. It is to be placed on record that the student is neither asking for any re-checking nor re-totaling of his answer sheet. Similarly, this Commission is not asking for the same. Hence, with respect, the above referred decision of August Supreme Court, is not attracted to these Proceedings.

It has been held in various jurisdictions of the world that answer sheet is an information held by the examining Bodies and the citizens, in the spirit of transparency and good governance, have a right to access such information under the Right to Information Act recognized all over the world. This Commission had previously favored the supply of answer sheet to the students and its decision have been implemented by Public Bodies like Public Service Commission and Provincial Assembly of Khyber Pakhtunkhwa. In this background, this Commission is of the view that University of Science & Technology, Bannu should not be, and cannot be, an exception. Therefore, University Authorities are directed to provide a copy of the script to the complainant within three days of the receipt of this Order.
