

The second information sought by the complainant is the copy of declaration of assets filed by the Vice Chancellor. It is strange that the PIO on 25th May, 2015 informed this Commission that the complainant should approach Federal Board of Revenue for this purpose. Section 9(I) of the Right to Information Act, 2013 has been referred for this refusal. Section 9 of the Act is in respect of third party information. It has been ruled by this Commission time and again that all the documents submitted by a public servant in his capacity as such are public documents and these are subject to the RTI requests. The learned Vice Chancellor declared his assets in his capacity as public servant and hence his assets should not only be available to the complainant but should also be published on the official website. Hence assets of a government servant are not third party information and shall have to be provided to the complainant. The PIO is directed to ask the concerned section for the supply of information within 24 hours through e-mail and intimate this Commission by fax or e-mail. If the information is not provided then the Law will take its own course.




