The Right to Information Commission (RTIC) was established through an Act of the Provincial Assembly of Khyber Pakhtunkhwa in November 2013, thereby endorsing Article 19-A of the Constitution of Pakistan, empowering citizens to have access to information for transparency and good governance. The RTI Commission thus aims to enable citizens to enjoy their constitutional right to obtain information.

The role of this Commission is interactive. On the one hand it encourages citizens to know about their right to access information which in the past was out of their reach in public offices, while on the other hand it urges and supports public bodies in implementing the RTI Law and to realize and understand their duties and responsibilities under the same.

The Commission plays an equally monumental role in investing people with confidence and self-esteem to approach any public body for whatever information they require. This Commission is looking forward to active participation by citizens, the civil society and the time bound responses by all public bodies. This will ensure transparency and good governance which is the ultimate goal of the Law.

## **VISION**

To safeguard the constitutional right of citizens to access information of public importance, thus enabling citizens to be involved in public affairs, thereby ensuring transparency in all matters, besides establishing a sense of citizenship, both in the general public and public organizations to meet the challenges of a democratic culture and its emerging issues.

## **MISSION STATEMENT**

To enhance awareness amongst the people of the province that they have every right under this law to access information regarding any issue of public importance thereby having the opportunity to play their role in improving governance.

## KHYYBER PAKHTUNKHWA RIGHT TO INFORMATION LAW

### INTRODUCTION:

‘To know’ is a basic human instinct and this urge has been one of the basic causes of friction between rulers and the ruled throughout history. Whether the public has a right to know as to how the king is taking decisions, has been the subject of discussion over the centuries. How much the public should know and at what cost has also been debated. During the last century or so, civilized societies not only recognized this right as a basic human right but also enacted laws to give it a formal and binding shape.

The story of Pakistan is no different. A country, where three generations were brought up under the culture of secrecy, (Official Secrets Act 1923), many officers and public bodies could not digest this human right easily. It was during the debate on the 18<sup>th</sup> amendment that Article 19-A was added to the Constitution, making it one of the fundamental rights of the people of Pakistan. The province of Khyber Pakhtunkhwa took the lead to formalize this right and the present Assembly deserves an honorable mention in passing this law in 2013.

The law itself is forward-looking and progressive and is being hailed inside and outside the country. The beauty of the law is that it provides a time-line for supply of information and also provides a forum to hear complaints against the non provision of information sought from a public body. An independent Information Commission is the hallmark of the entire scheme, having the power not only to ensure and enforce supply of information but also to punish any delinquent official.

**GENESIS:**

“A popular Government, without popular information, or the means of acquiring it, is but a prologue to a farce or a tragedy; or, perhaps both. Knowledge will forever govern ignorance; and people who mean to be their own Governors, must arm themselves with the power which knowledge gives.” James Madison, (4<sup>th</sup> President of the USA.)

If democracy cannot function without informed citizens, then neither can it function without freedom of information. It is for this basic reason that more and more countries are adopting freedom of information laws in the belief that it is bound to result in transparency, accountability and a culture of openness.

The Right to Information, though a recent enactment in the province, has its roots in history. According to Islamic tradition, Hazrat Umar, the second Caliph of Islam, was during the Friday prayers questioned by an ordinary citizen as to how come he (the Caliph) had a shirt stitched out of the Maal-e-Ghanimat cloth, which all had received and which was insufficient to make a shirt. The son of Hazrat Umar is reported to have responded on behalf of the father saying that as the cloth was insufficient for both to have shirts made, thus he had given his piece of cloth to his father and hence the Caliph had a new shirt. This tradition thus demonstrates that the right to seek information is as old as history goes, even though then it was not termed so.

The present institution of the Right to Information was formally introduced in Sweden in 1776 when a Finnish priest by the name of Anders Chydenius, through his writings and in his debates in the Diet, led to a stricter parliamentary control on the Government budget. The first law when enacted was largely motivated by the parliament's interest in access to information which was held by the king. Chydenius greatest achievement was towards the extension of freedom of

the press of which he was a great proponent. His statement that “No evidence should be needed that a certain freedom of writing and printing is one of the strongest bulwarks of a free organization of the state, as without it the estates would not have sufficient information for the drafting of good laws, and those dispensing justice would not be monitored, nor would the subjects know the requirements of the law, the limits of the Government and their own responsibilities. Education and good conduct would be crushed, coarseness in thought, speech and manners would prevail and dimness would darken the entire sky of our freedom in a few years,” shows how much has been achieved in these last 250 years.

The United Nations General Assembly passed its resolution declaring freedom of information as a basic human right in 1948. It was subsequently picked up by the United States of America in 1966. Thereafter other nations in northern Europe introduced the same and thus accelerated the process so much so that by the end of 2014 almost 100 countries the world over had adopted the same.

Access to information in Khyber Pakhtunkhwa was limited or negligible before the passing of Right to Information Act, 2013. Citizens were not aware of the services/functions of the government or their right for seeking information. Public information dissemination in KPK was weak and inconsistent and important information of public concern was generally kept secret.

The Right to Information Act 2013 passed by the KPK Assembly in November, 2013 is assessed to be one of the most outstanding pieces of legislation passed by the Provincial Assembly since independence. The buzz words “Good Governance and transparency” which are used in the context of RTI are absolutely on the mark as the Act leads to transparency and accountability. It is also participatory, effective and efficient.



Its successful implementation however is directly co related to the level of commitment of the Government, the political parties and the designated officers. It is, therefore, imperative that a large scale publicity of the benefits of the Act is made and full support is provided to all those who are tasked with the implementation of the RTI law.

### **THE COMMISSION:**

The RTI Commission established under the RTI Law is an independent statutory body headed by the Chief Information Commissioner who is assisted by two Commissioners.

Under Section 25(1) of the Right to Information Act, 2013 the primary responsibility of the Commission is to receive and decide on complaints. If a citizen files a complaint against a public body for not being provided the information he requested for, the Commission after hearing the citizen and the public body takes a decision.

The Commission is also tasked with creating awareness and to ensure that the public bodies pro-actively display their records especially through the Web, so that citizens can seek whatever information they desire without visiting public offices.

Section 25(2)(g) of the Right to Information Act, 2013 makes it obligatory on the Information Commission to compile a comprehensive annual report both describing its own activities, including an overview of its audited accounts, and providing an overview of the activities undertaken by all public bodies to implement this Act, taking into account the information provided by individual public bodies pursuant to section 5(2) of the RTI Act, 2013.

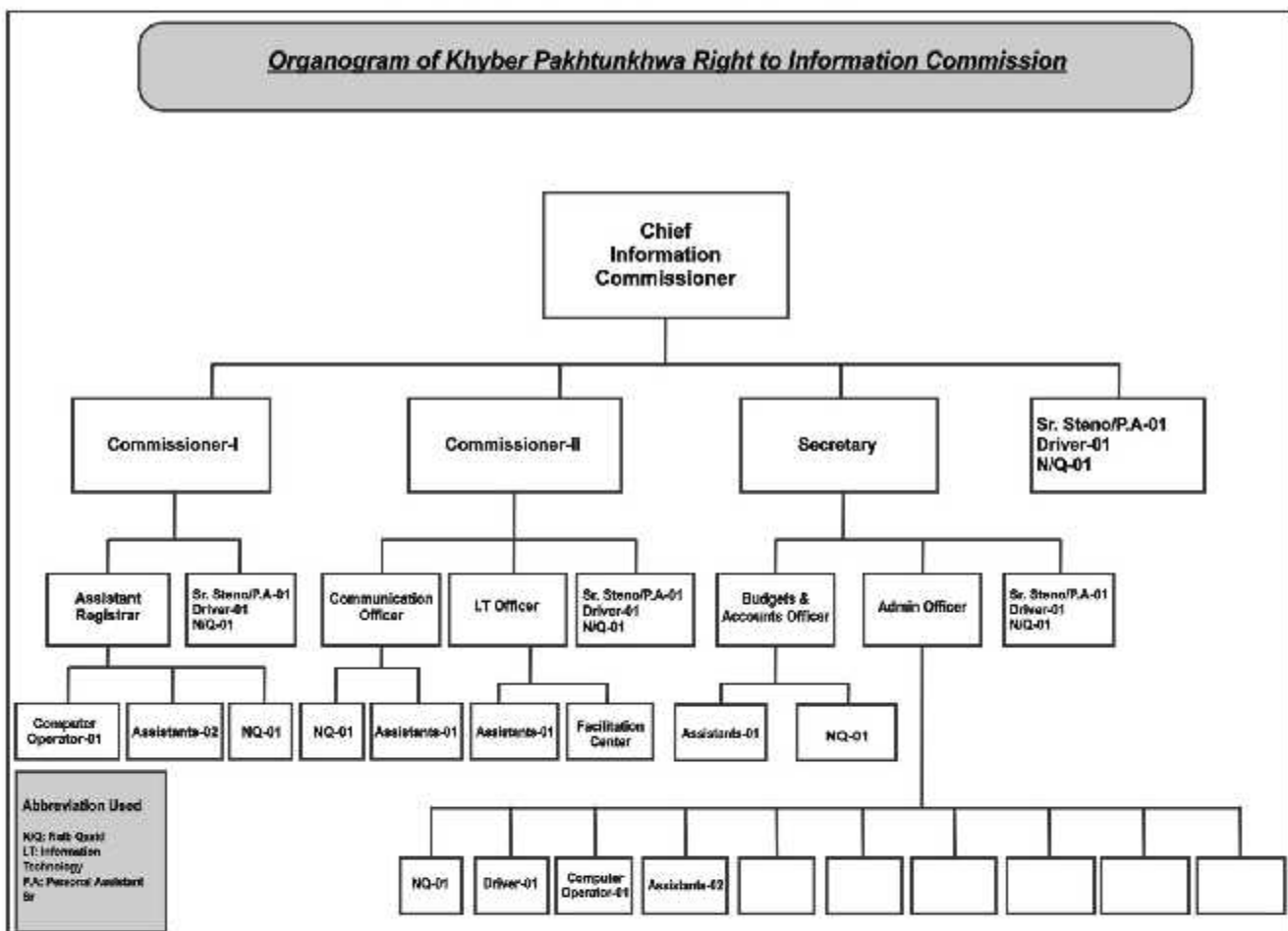
As per section 25(2)(g) of the Act, the Right to Information Commission is presenting this Annual Report. However audited accounts cannot be included in the report, as the Grant-in-Aid by the government has been released to the Information Commission during October 2014 (for 2014-15) and their accounts for 2014-15 could only be presented for audit after closing of the fiscal year i.e. 30<sup>th</sup> June, 2015; therefore the audited figures will be intimated separately and included in the next year's annual report. In this annual report the analysis of the annual reports of

the other public bodies has also not been reported as a very negligible number of public bodies have furnished their annual reports in accordance with the provisions of section 5(2) of the Right to Information Act, 2013. Those public bodies which have furnished their reports are incomplete which only contains the number of requests received and disposed off, attached at Annexure-4.

**THE COMMISSION'S SECRETARIAT:**

At present the Commission is working with five wings/sections, namely Communication, Legal, IT, Budget and Accounts and Administration.

**ORGANIZATIONAL STRUCTURE:**



**The COMMUNICATION SECTION** of the KPK RTI Commission liaises with media to create awareness in the masses and public bodies. It also publishes newsletters, pamphlets, booklets and carries out correspondence with other organizations/departments in the context of

RTI law. The Communication Section also arranges press briefings, workshops and seminars for Businessmen/traders community, Academia students and civil society members for awareness about the Law.

As the law places crucial duties and responsibilities on the designated Public Information Officer (PIO) who has to serve as the lynch pin between the public and the respective public body, for processing citizens requests for information sought under the RTI law, the Communication Section arranged training workshops for PIOs, from time to time, on one hand and carried out various awareness campaigns through print and electronic media for public on the other hand for better outcomes by implementing the law in its true spirit.

**The LEGAL SECTION** of the KPK RTI Commission registers complaints against Departments/Public Bodies and issues instructions to them for provision of requested information to the complainants. It also issues summons to PIO's to appear before the Commission for recording views. The legal section advises the public bodies whenever there is a confusion regarding an information being exempt or otherwise.

One of the most important activities of the Legal Section is to record the proceedings and draft orders of the Commission besides maintaining case files/record.

**The ADMINISTRATION SECTION** of the KPK RTI Commission is responsible for all administrative and establishment affairs. It maintains all records and files of the employees. The Administration Section is also responsible for security management and maintenance of cash book for imprest Money/Permanent Advance.

The Section also corresponds with other Organizations/Departments with regard to matters assigned to the Administration Section and supervises the Diary and Dispatch record. Maintenance of record of all the items purchased for the Commission is also the responsibility of this Section.

**The IT SECTION** keeps liaison with officers designated by the public bodies as Public Information Officers (PIOs) and receives reports about requests submitted with PIOs and the status of action on the same.

The IT section is also tasked to maintain and update lists and other particulars of PIOs and to facilitate other sections of the RTI Commission about IT related matters.

Maintenance of Right to Information Commission's Website and uploading of activities of the Commission on Website is also one of the responsibilities of the IT section of the Commission (see Bar chart on Page 27-28)

**The BUDGET & ACCOUNTS SECTION** is responsible for preparation of budget proposal for Commission to be sent to the Finance department in the light of Section 27(2) of the RTI Act 2013. On receipt of grant from the government, this section makes proposals for item wise distribution of funds. Funds are allocated to their respective heads according to their volume of transaction.

This section is responsible for maintaining books of accounts of the Commission's expenditures, prepares monthly payroll of all the officers and officials of the Commission and also deals with preparation of bank reconciliation and preparation of tax chalang.

## **ACHIEVEMENTS:**

After enactment of the RTI law in November, 2013, the Chief Information Commissioner was appointed. In March 2014, the remaining two Commissioners were appointed with which the Commission started its functions. First of all the Commission asked all public bodies to appoint the designated officers (PIOs) and notify their names under intimation to the RTI Commission. Accordingly 556 officers, till March 31<sup>st</sup> 2015, were appointed by the public bodies as designated officers (PIOs).

During one year of its establishment 1767 requests were filed with various PIOs by the requesters seeking information. Out of these, 1197 requests were disposed off by providing the required information. The remaining 54 requests are in process with the public bodies, whereas in



516 cases, the requesters were not satisfied with the response of the Public body and as such the requesters lodged complaints in these cases before the RTI Commission ( see table-I, Pie chart-I).

Under section 25(1) of the RTI Act, 2013, the primary responsibility of the RTI Commission is to receive and decide the complaints. Under section 23(1) of the RTI Act, 2013, any citizen who believes that his request has not been dealt in accordance with the provision of RTI Act, has the right to lodge a complaint with the Information Commission.

The Right to Information Commission had received 516 complaints till 31<sup>st</sup> March 2015. Out of these 434 Complaints have been disposed off as the public bodies have provided the required information to the satisfaction of the complainants after intervention by the RTI Commission. The remaining 82 complaints are under the active consideration of the Commission (see table-II, Bar Chart on Page 25-26)\

Moreover, the RTI Commission with the financial and technical assistance of Center for Governance and Public Accountability (CGPA), a non-governmental organization, established a Toll Free call center where citizens can call and get all relevant information regarding Right to Information law.

The RTI Commission organized various seminars and workshops for the awareness of public about RTI law. The details of seminars and workshops are as under:

- 1) 20<sup>th</sup> March 2014. One day training workshop for PIOs at DI Khan
- 2) 02<sup>nd</sup> April 2014. One day training workshop for PIOs at Mardan
- 3) 15<sup>th</sup> April 2014. One day training workshop for PIOs at Kohat
- 4) 29<sup>th</sup> April 2014. One day training workshop for PIOs at Peshawar
- 5) 27<sup>th</sup> May 2014. One day training workshop for PIOs at Abbottabad
- 6) 03<sup>rd</sup> June 2014. One day training workshop for PIOs at Manshra
- 7) July 2014. Interactive seminar for traders/business community at Khyber Chamber of Commerce and Industry Peshawar.
- 8) 22<sup>nd</sup> October 2014. One day interactive seminar for students at Edwardes College Peshawar.
- 9) 29<sup>th</sup> October 2014. One day interactive semi
- 10) nar for students at Khyber Law College UoP.

Besides the seminars and workshops public awareness programmes were also initiated as under.

- 1) Public awareness advertisement through local and national daily newspapers.
- 2) Published list of PIOs in various print media outlets in relevance with international "Right to Know Day" on 28<sup>th</sup> September 2014.
- 3) An awareness advertisement campaign for masses through Radio stations FM-101, FM-93, FM-94, FM-88 and FM-100 were broadcasted on daily basis from December, 2014 to January 2015 in eleven districts with the financial support of CESSD.
- 4) A three-month awareness advertisement campaign for masses was carried out through PTV and AVT Khyber television channels from July to September, 2014.
- 5) For the guidance of citizens and PIOs, the Commission published and distributed two booklets in order to understand their role and responsibilities under KP RTI Act, 2013.
- 6) Hoarding boards carrying public awareness messages on KP RTI law were arranged at various locations.
- 7) Pamphlets and posters for informing citizens of their rights under the law were also published and distributed among masses and PIOs.
- 8) For the awareness of masses and to understand the law in its true spirit, the RTI Act 2013, was translated into Urdu with the financial and technical assistance of Citizen Engagement for Social Service Delivery (CESSD), a non-governmental organization, and was distributed among masses and PIOs.

In addition to these awareness activities for the public, training programs for the designated officers (PIOs) was also carried out as under

- 1) Two-Day training workshops for 250 PIOs at Khyber Pakhtunkhwa Judicial Academy regarding how to perform their duties under RTI law in eight different groups from June 2014 to July 2014.
- 2) Two-Day training workshops for 240 PIOs at Pakistan Provincial Services Academy Peshawar (PPSA) in six groups from December 2014 to February 2015 regarding PIOs role and responsibilities under RTI law.

## **CHALLENGES:**

Since its establishment, the KPK RTI Commission has kept a constant interaction with a cross section of society. During the course of the last one year, the Commission, through different activities like seminars, workshops, training sessions for PIOs, official correspondence and inspection visits of various public bodies, came across certain issues and problems that need to be addressed on priority basis for ensuring transparency for good governance in the province.

### **1. Mindset Change:**

The biggest challenge being faced is changing the mindset of government officials. The spirit of this law is a complete paradigm shift in the historical perspective of governance, so it demands a change in attitude/mindset. All government officials, who till the passing of this law, had been governed by the Official Secrets Act 1923, and E&D Rules, find it hard to change their erstwhile mindset and digest this revolutionary Act, which says, “nothing is secret but there are some exemptions.” It is hoped that with the passage of time and of course a lot of efforts, the officials/public bodies will accept this U-turn and will embrace the change and use it as a tool to spread the light.

### **2. Awareness activities:**

In spite of advertising the RTI law through the print and electronic media, seminars and workshops at provincial and divisional levels, the desired goal of mass awareness in urban and rural areas is yet to be achieved and as such new strategies have to be adopted towards this end.

Furthermore very few, if any, PIOs have displayed any signboard in front of their offices as required by the RTI law, to facilitate citizens in approaching them easily in their respective offices in spite of the PIOs being reminded time and again to do so.

### 3. Updating of Websites.

Although it has been clearly stated in Section-5 of the RTI Act, there are very few provincial departments and other institutions/public bodies who have updated websites which display their mandate, the activities they carry out, their rules and regulations, roles and responsibilities of their officers, their budget and projects etc. This Commission has repeatedly reminded this legal obligation of the public bodies but with very little or no success. If the websites of the Public bodies are regularly updated, there will hardly be any room for any request or complaint as the information which requester desires would be available on the website.

### 4. Lack of IT literacy:

In majority of cases, the PIOs are neither computer literate nor have access to this facility which results in the slow processing of the requests at the primary level. This issue needs to be addressed on priority basis. If tools are made available, skills would develop as a natural corollary.

### 5. Change of PIOs.

Frequent postings and transfers phenomenon of PIOs results in delayed responses to requests for the provision of information as a result of which the requests change into complaints. It also enhances the difficulties of the Commission as new hands are not only hard to train but new minds are harder to orient which is a time-consuming process.

Besides this, the list of PIO's is manually updated through phone calls, which is a tedious and time consuming task. Mostly the round of calls take 2-3 weeks wherein at times PIOs are inaccessible through phones and when the next round of calls is initiated it is learnt that there are a number of PIOs who have been transferred and the names of new PIOs are not

intimated in time. PIOs and public bodies have been and are constantly being reminded to inform the RTIC at the earliest about the names and designations of new PIOs.

6. **Difficult liaison.**

To liaise with more than 500 PIOs for getting details about requests on daily basis, is practically very difficult for the RTI Commission with its limited resources and staff.

7. **PIO duties; an additional responsibility.**

Officials of various Public bodies working as PIOs see this as an additional responsibility and burden without any incentives.

8. **Annual Report by Public Bodies.**

Under section 5(2) of the RTI Act, 2013, every public body is bound to publish its annual report about what it has done to implement its obligations under the RTI Act. The report shall include detailed information about the requests for information which the public body received and how it processed these requests.

The annual report is to be formally forwarded to the Speaker Provincial Assembly of Khyber Pakhtunkhwa and to the Information Commission, who is required to take such action on the report as it may deem appropriate.

9. **Time limit for lodging complaints.**

The present legal position is that whenever a citizen files an RTI request, he must receive response within a maximum of 20 days. Failure by a Public body to respond to the request, a citizen can lodge complaint with Information Commission. No limitation has been placed on this right of the citizen. The commission feels that providing a time line for filing a complaint would even the balance.

10. **Non attestation of documents provided.**

The Commissions feels the filing of a complaint by a citizen should be time bound. The public bodies have been time and again informed to adopt the practice of providing attested documents in the true spirit of RTI ACT 2013.



**SUGGESTIONS:**

During the last one year (period under review) quite a few issues were encountered and solutions found for the same. All the same, the following issues, which still continue being faced, need mention.

**1. Pro Active Disclosure.**

It is imperative that all public bodies ensure that they have their websites as per section 5 of the RTI Act, displaying an updated list of PIOs of their respective public bodies. (In doing so, a suitable feature shall be formulated to integrate lists of all PIOs from their concerned public bodies' website and compiled collectively on the RTI website.) This will mitigate and in longer terms eliminate the redundant manual process of obtaining PIOs lists and their contact information. It will also ensure availability of timely and up to date information available both to the RTI Commission and citizens.

Besides, it was observed that half of the requests lodged were related to the provision of seniority lists of employees, minutes of the Provincial Selection Board (PSB) and other meetings, seniority list for allotment of accommodation, results of tests/interviews which have been conducted, their budget and projects completed/in hand etc. It would be beneficial for the public bodies if the aforementioned documents are placed on the websites of all public bodies immediately once the same are finalized. This shall show that the govt/officials are ensuring transparency.

**2. Unnecessary delay in response.**

During the year it was also observed that requests of citizens were unnecessarily delayed primarily due to the slow procedural practices in the government offices, resulting in the request

reaching the PIO very late. Thereafter if the information was not available with the PIO, then instead of asking for the same on telephone from any subordinate or colleague's office, the PIO would send out his own letter to seek the information. This indulgence in unnecessary paperwork inevitably leads to delay due to which the requester is forced to lodge a complaint with the RTIC "demanding" that action be taken under the law against the PIO for not providing the information sought within the stipulated time frame.

It is suggested that the PIOs, should start processing the request for information at once so as to comply with the time frame under the KP RTI law without involving the office of the Head of Department/institution. It needs to be impressed upon the PIOs that they are appointed by the Public Body under the law and they are not required to seek approval of the Head of Department for supply of information.

**3. Display of name, numbers and official email addresses.**

Besides, to ensure that every public body has its PIO; it must display on its website, the list of PIOs along with their contact numbers including Cell number, office number, Fax number and "official" Email address.

**4. For better liaison.**

It will be appropriate that there should be a senior officer in every administrative department to be appointed by the administrative secretary concerned to act as "coordinator for RTI." He will collect the data regarding filing of requests and action taken by the PIOs of the offices subordinate to the respective administrative department. The coordinator will update the data on daily basis, upload it on the official website of the department concerned and also will send it to RTI Commission electronically for updating the RTI Commission's website.

For this additional duty, the government will be approached to sanction special incentive for the coordinators, besides providing them laptop or desktop computers for this specific assignment.

On transfer or relieving the coordinator of the said department, the administrative secretary concerned should immediately appoint another officer and intimate his particulars to the RTI Commission.

#### **5. PIO's problems.**

The Commission has successfully completed one year during which extensive media coverage was given in national media and through news items (special features on RTI Law, Events and News and advertisements) and through awareness messages aired through TV/Radio, resulting in citizens filing large number of applications in government departments. This 'new' trend of citizens seeking information from public bodies compelled several PIOs to request their concerned offices to be allowed to relinquish charge of the responsibilities of working as PIOs arguing that it had become increasingly difficult for them to perform their duties as PIOs along with their routine departmental duties.

Furthermore, non-provision of incentives from the government with regard to their additional duties as PIO in the shape of additional pay/honoraria was also a reason given by some PIOs to give up working in that capacity. It is, therefore, suggested that there should be some incentives for PIOs in the shape of certain benefits (honoraria etc.) while working on the post apart from other official duties in the respective public body.

**6. Mobile phones.**

Every PIO should be issued an official mobile number to receive messages regarding RTI requests and complaints on web-portal.

**7. Action on publishing Annual Report.**

For implementation of the provisions of the Right to Information Act, 2013 in letter and spirit regarding publishing of annual report, it is suggested that the Speaker of the Khyber Pakhtunkhwa Provincial Assembly may ask the public bodies to clarify their position for not doing their obligatory duty under the law of the Right to Information.

**8. Inclusion in syllabus.**

The KPK RTI law should be included in the syllabi of educational institutions at the matriculation, intermediate or Bachelor's level.

Besides, the Official Secrets Act 1923, Efficiency and Discipline Rules and Rules of Businesses should be modified in the light of KP RTI law.

**9. Scope of Exemption.**

Section 14 (1) of the RTI Act, 2013 provides exemption to provide information in a few specified areas and says that the secrecy provisions under any other law may not extend the scope of the exemption as provided in the RTI Act. In other words the provisions for not providing information in any other law stands redundant and ineffective if a request for information is filed by a citizen. Only the exemption provisions of the RTI Act, 2013 would prevail over all the previous laws.



It will be appropriate that the Law Department may look into this and propose amendments in all other laws, which have the provisions of not providing information for the reason of secrecy, so that these laws become RTI friendly.

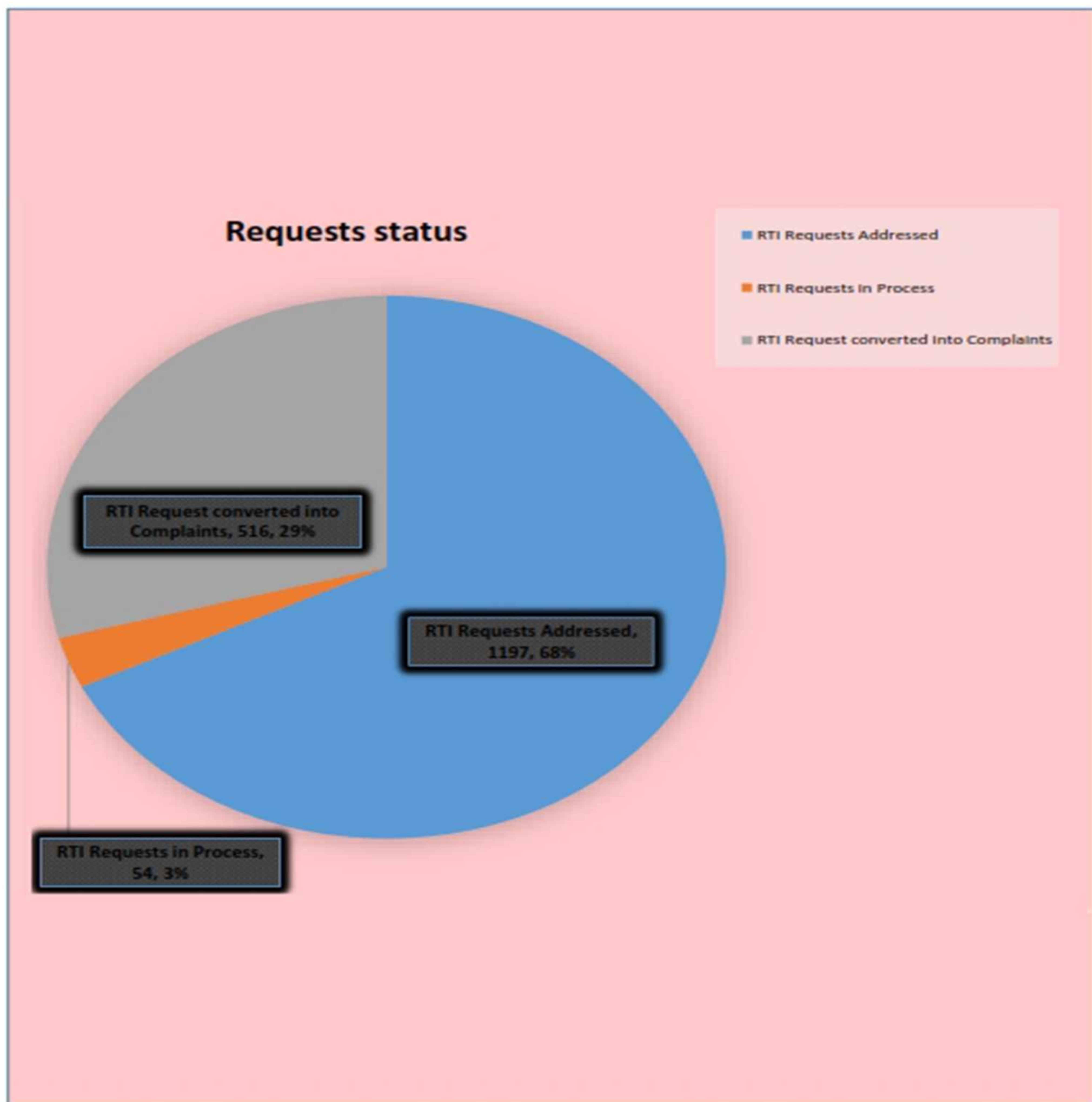

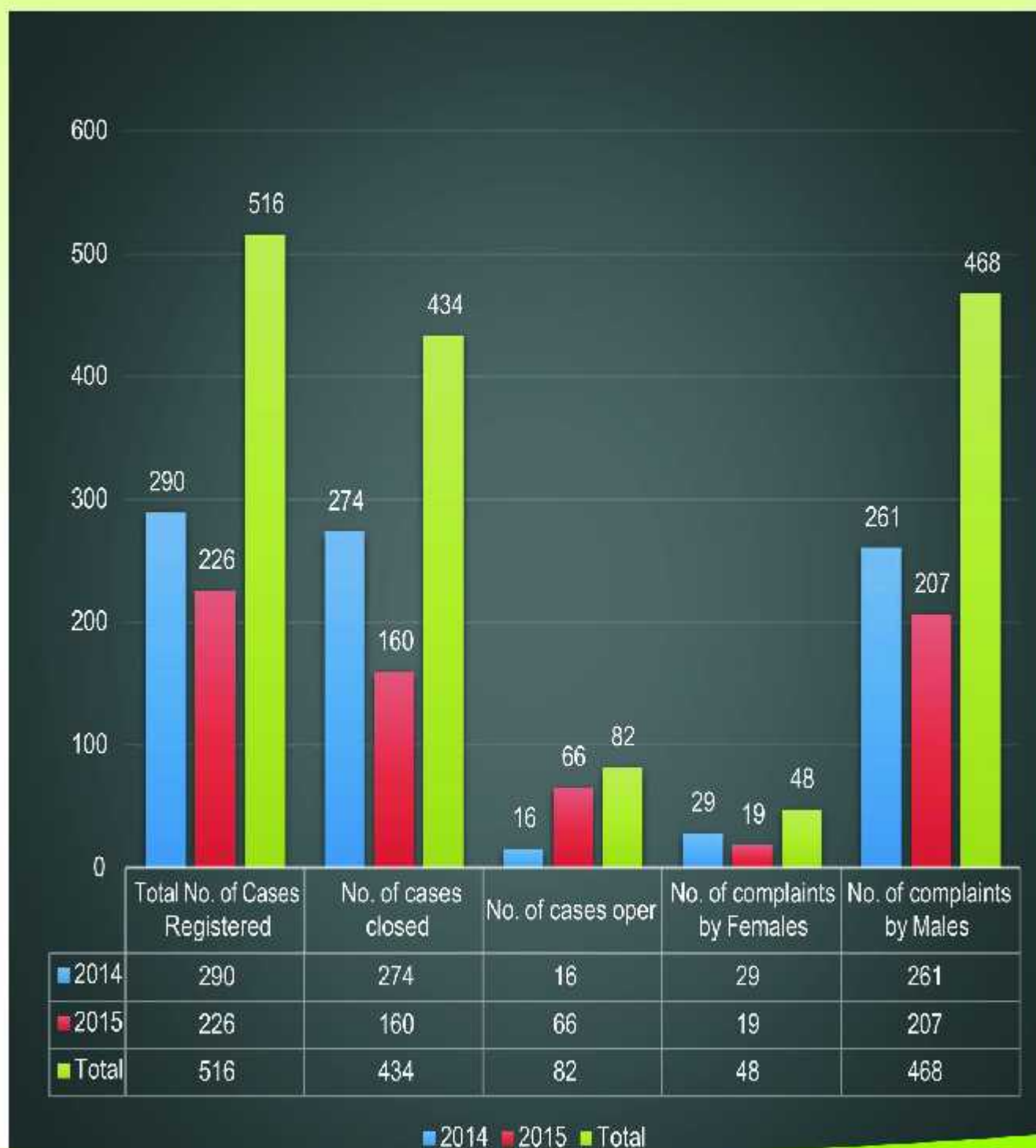

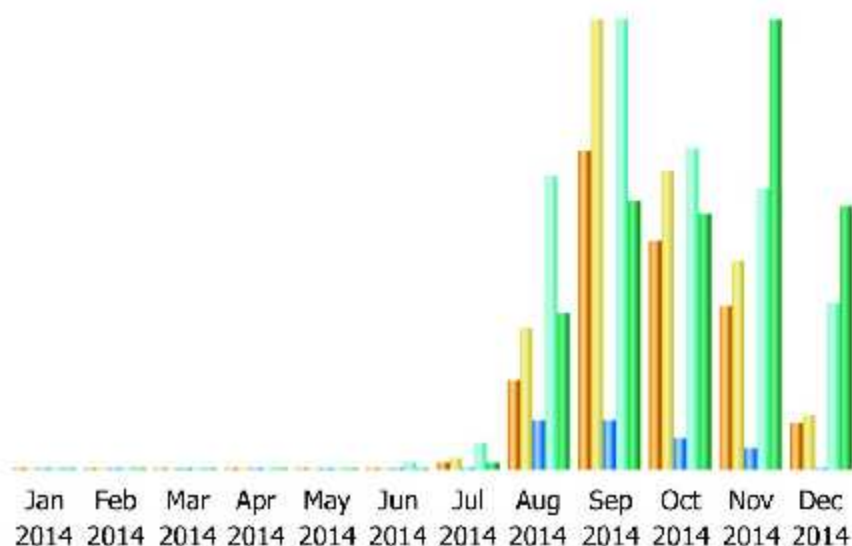
## Bar Chart-I

Statistics of KP RTI Commission website visits since 1<sup>st</sup> May 2014 till 31<sup>st</sup> December 2014.

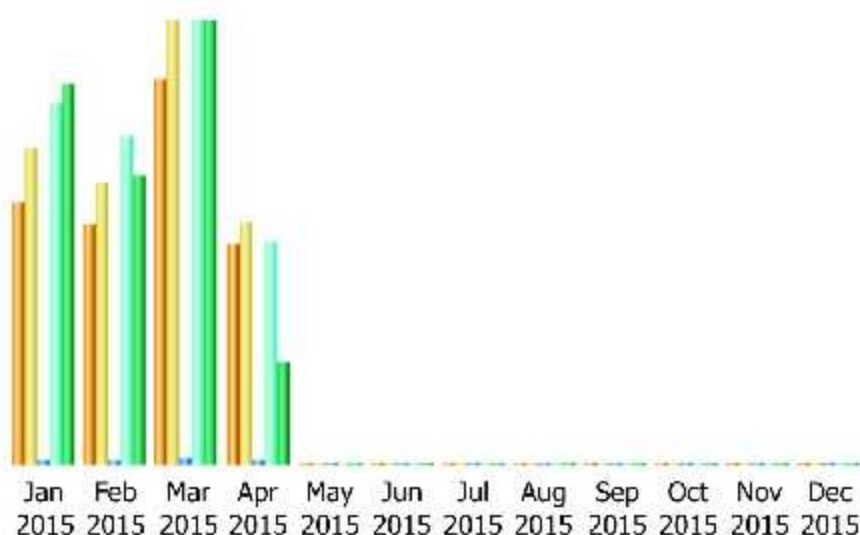

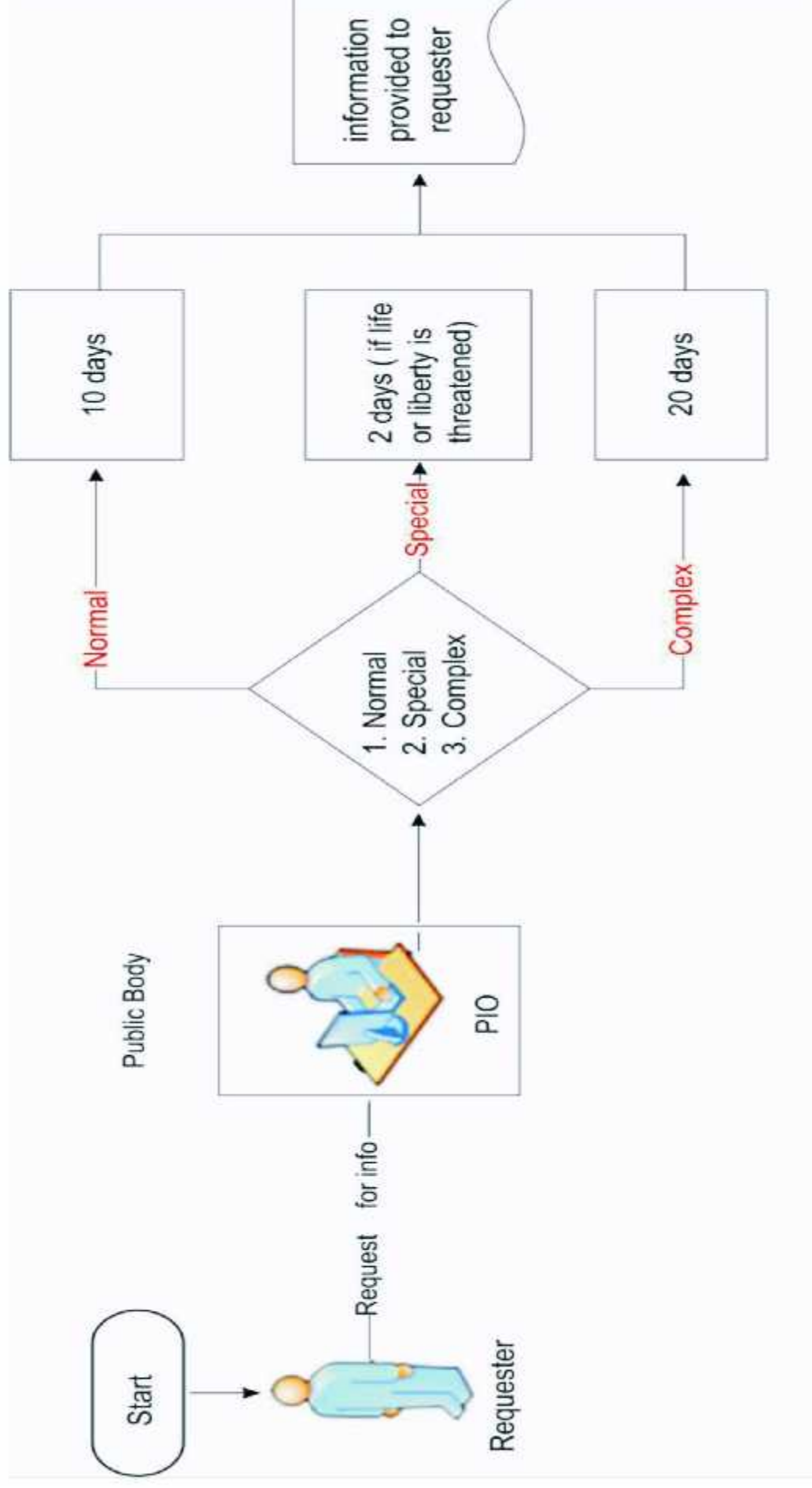

Statistics of KP RTI Commission website's visits since 1<sup>st</sup> January 2015 till 31<sup>st</sup> March 2015.

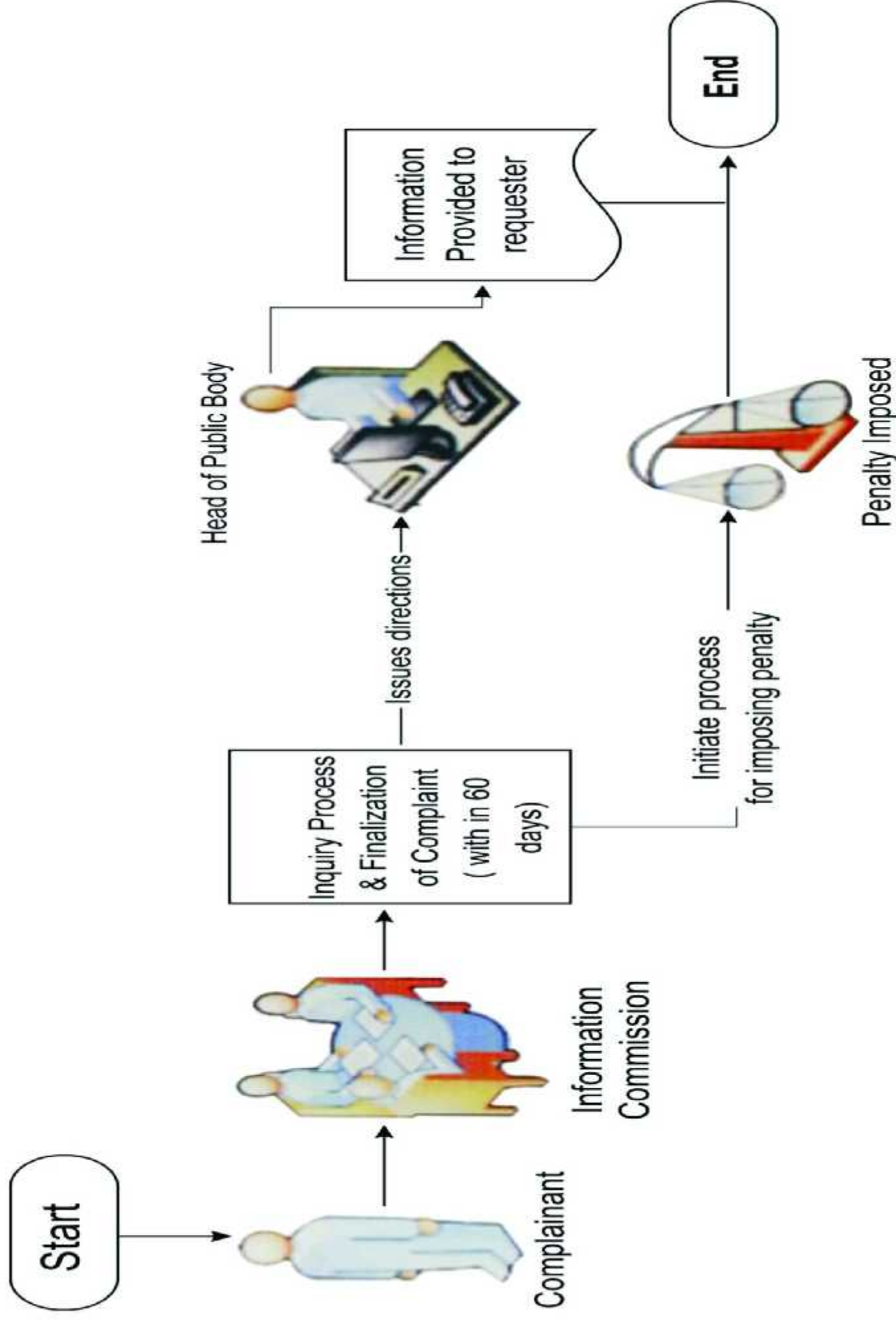
