OFFICE ORDER

No. AO/RTI/2-9/2016/ 2771. On the recommendation of the Selection Committee and on acceptance of offer for appointment, the Right to Information Commission has been pleased to appoint **Mr. Muhammad Tahir s/o Afzal Haq** against the existing vacant post of I.T Officer (BPS-17) with effect from his date of arrival i.e. 11<sup>th</sup> January 2016, on the following terms & conditions:-

- 1) He will get pay at the minimum of BPS-17 including usual allowances as admissible under the rules. He will also be entitled to annual increment as per policy of the Commission;
- 2) He shall be governed by all the laws /rules applicable to the employees of Right to Information Commission Khyber Pakhtunkhwa.
- 3) He shall be initially, on probation for a period of one year extendable for a further period of one year;
- 4) In case he wishes to resign at any time, fourteen days notice shall be necessary or in lieu thereof fourteen days pay shall be forfeited.
- 5) He shall produce a medical certificate of fitness from Medical Superintendent, Civil Hospital Peshawar and character certificate from two gazetted officers;
- 6) His retention in service shall be subject to verification of his domicile, testimonials and antecedents etc, from the concerned authorities /offices;
- 7) His appointment is on temporary basis and liable to be terminated at any time without assigning any reason before the expiry of the period of probation /extended period of probation;
- 8) In case he is in service in any department/organization he shall produce the relieving order from his Parent Department/Organization clearly indicating that no disciplinary action is pending against him; and
- 9) He will join duty at his own expenses, as no TA/DA shall be admissible there-of;
- 10) His inter-se seniority will be determined in accordance with the rules / regulations as applicable to the employees of RTI Commission.
