MR. AZIZ UR RAHMAN VS. KPK PROVINCIAL ASSEMBLY, PESHAWAR (COMPLAINT NO. 03776)

ORDER

The brief facts of the case are that Mr. Aziz Ur Rehman filed a request on <u>07-07-2017</u> wherein he requested for the information relating to the details of foreign visits as well as expenditure incurred on foreign visits of the Parliamentarians & staff of the Provincial Assembly Secretariat. The required information was not provided.

Therefore he lodged a complaint at the RTI Commission on <u>11-09-2017</u>.

Accordingly directions were issued to the PIO on <u>06-10-2017</u> for providing information. Whereas the PIO provided him the partial information vide the letter no: <u>PA/KP/PS/2018</u>, dated: <u>18-04-2018</u>, however the complainant complained that the details of expenditures incurred on the tours were not provided. Directions were again issued to the PIO to provide complete information but to no avail.

Since information was being persistently denied by the PIO hence a showcause notice was issued on <u>01-10-2018</u>. In reply to showcause notice the PIO stated vide their letter no: <u>PA/KP/PS/2018/6880</u>, dated: <u>31st October, 2018</u>, that the entire information i.e. the perk & privileges of the parliamentarian & Staff of the Provincial Assembly Secretariat were available on the website, & that the complainant could download the same from the website. Upon checking the website being referred to above. It was observed that only the rates of Daily

Allowance notified by the finance department vide the notification no:

FD(SOSR.II)8-52/2007, dated: 06-04-2007 which is not been updated. The chance

of personal hearing was also afforded to the PIO but no information provided

rather the same plea was raised that the information was available on the website.

Whereas only daily allowance has been mentioned on the said link. For the last

one year, the PIO is repeatedly directed by the RTI Commission to provide

information regarding the expenditures but he falled to fulfil the directions of this

Commission.

In the light of the observations above it is abundantly clear that PIO is persistently

delaying & denying the information. Hence there left no option but to invoke the

provision under section 26(3)(b) of the RTI Act; 2013. Therefore in exercise of the

powers conferred under this section a fine of Rs. 10,000 is imposed upon Mr. Atta

ullah Khan, Special Secretary IT/PIO. The fine amount should be deposited under

the head of account C03841. It is further added that imposition of fine on the PIO

does not absolve him of his obligation to provide the desired information to the

complainant. He should provide information within 10 days receiving of this order.
