That the requester filed a complaint with this Commission on 29/04/2014 against your failure to respond to his request;

NOWTHEREFOR, you are directed, to show cause as to why a Fine of Rs. 25000/ should not be imposed on you in the letter and spirit of Sec. 26 (3)(b) of the RTI Act 2013.

Your reply should reach this Office within fourteen days of the receipt of this Notice, failing which it shall be presumed that you have no cause to show.

That you were called for a meeting into the Commission on 31/10/14 in which meeting you repeated your stance not to provide the said information.
