ANDWHEREAS, you have now informed that the said Minutes cannot be disclosed and cannot be made public;


ANDWHEREAS, you have failed to carry out the commitments made with this Commission on **02<sup>nd</sup> September, 2015**;

Your reply should reach this office within **fourteen** days of the receipt of this notice failing which it shall be presumed that you have no cause to show.
