The Commission therefore, decided to direct the public body to provide the requested information to the complainant within seven (7) working days positively.

It was further decided that in case of failure to comply with the directions, the Commission would be constrained to invoke the penal provisions of Section 26 read with Section 28 of the KP RTI Act, 2013.
