ORDER

Mr. Saeed Nawaz, Assistant Director, Representative of the Urban Area Development Authority, Kohat (referred hereinafter as Public Body) appeared for hearing in the complaint No. 7945 before the Commission on 12th April, 2022 and explained that the complainant has been intimated to pay the photostate charges of the information so sought by the complainant vide letter No. 313/UADA/52.m dated: 02-09-2021 with a copy endorsed to the Commission but the complainant has not deposited the charges. However, the representative of the Public Body assured the Commission that the specific record sought by the complainant would be provided on payment of photostate charges.
