RESPECTFULLY SHEWETH:

The Petitioner humbly submits as under:

- That the Petitioner is a statutory body constituted under Khyber Pakhtunkhwa Board of Intermediate and Secondary Education Act 1990.
- 2) That the Respondent No. 2 appeared in SSC Annual Examination 2015 under Roll No. 36325.
- 3) That the result of the said examination was declared and the Gazette Book was issued accordingly. (Copy of result Gazette is Annex: "A")
- 4) That the Respondent No. ⊉ applied for retotalling of Chemistry, Maths and Urdu papers under the Board Rules which was accepted and papers were put to the subject experts for retotalling but no discrepancy was found in the papers of Maths and Urdu, however, 16 marks were increased in the subject of Chemistry. (Copies of application and notification Annex: "B" and "C" respectively)
- 5) That thereafter the Respondent No. 1 applied to Respondent No. 3 for issuance of direction to the Petitioner to provide the photo copies of the answer books of the Respondent No.1.
- 6) That the Respondent No. 6 on the complaint of Respondent No. 1 issued a letter dated 02/092015 which was dully replied by the Controller of Examination vide letter dated 18/09/2015. (Copy is Annex: "D").
- 7) That the Respondent No. 6 vide letter dated 30/10/2015 directed the Petitioner to provide the copies of the answer books of Respondent No. 2 to the Respondent No. 1.
- 8) That Petitioner, being aggrieved from the illegal act and order of the Respondents No. 3 to 6 and having no other adequate and efficacious remedy, files this Constitutional Petition interalia on the following grounds;

#### **GROUNDS**

Deputy Registrar accordance with law, rules and policy on subject and acted in 2 0 NOV 2015

violation of Article 4 of the Constitution of Islamic Republic Pakistan, 1973 and unlawfully issued the impugned order, whi is unjust, unfair and hence not sustainable in the eye of law.

- B) That the impugned order of Respondents No. 2 to 6 is illegal unlawful and without jurisdiction as the photo copy of answer books can not be provided to the Respondent No. 1 under the Board rules.
- C) That as the answer book is not the Public document, therefore, under the law the Respondents No. 3 to 6 were not competent to issue the impugned order.
- D) That the impugned order is void, discriminatory, arbitrary and obliviously malafide.
- E) That if the order of the Respondents No. **2** to **6** is accepted then it would lead to dangerous consequences, it would open a door for every unsuccessful candidate to challenge result of his examination in Court, thus involving educational institutions into unending and unethical litigations and bringing whole system of examination in vogue at stake solemnity of educational institutions and process of examination could not be sacrificed on the altar of expediency.

For the aforesaid grounds/reasons and others to be stated at the time of arguments it is, therefore, respectfully prayed that the impugned order dated 30/10/2015 being illegal, unlawful and without jurisdiction may very kindly be set aside.





In essence, the grievance of the petitioner is that the impugned order whereby the Commission-II by invoking the provisions of Khyber Pakhtunkhwa Right To Information Act, 2013 directed the petitioner to provide photocopy of the answer sheet to the complainant, within three working days failing which punitive action will be taken against the respondents, is against law as the answer book is not a public document and could not be provided to candidate.

comments of the Initially respondents were called for, but despite repeated reminders the same could not be filed, at the very outset learned Law Officer, when confronted with the proposition as to whether the answer book is a public document and its copy could be provided to the candidate, he failed to persuade the Court, however stated that the word 'public document' is not defined in the Khyber Pakhtunkhwa Right to Information Act, 2013, whereas section 12 of the Act ibid provides that where an applicant has indicated a preferred means for accessing information, such

The controversy with regard to inspection of the answer papers raised before the august Supreme Court of Pakistan in case titled Abdul Hakim Hashmi...VS...Federal Public Service Commission (2002 SCMR 504) wherein it was ruled that the answer papers in all the subjects of examination are secrete documents and cannot be permitted to be inspected or seen by the candidates or their representative. Similarly the summoning of answer book by the High Court, even in its constitutional jurisdiction, was disapproved by the apex Court in the case titled BISE Lahore...VS...Mst. Saima Azad (1996 SCMR 676). Admittedly the answer book of a candidate is not a public document and providing its copy to the candidate is not admissible by the state i.e. calendar of the Board. The worthy Commissioner by invoking the provisions of the Act, 2013 has acceded of
