**PROCEEDINGS**  
**(8<sup>th</sup> January, 2025)**

A citizen namely Sardar Hussain has filed an information request with District Accounts Office, Lakki Marwat on 24.07.2023 (Annex-A), which was required to be entertained as per Section 10 read with Section 11 of the KP RTI Act, 2013. However, the request of the citizen was not entertained in the prescribed manner; therefore, he has lodged a complaint before the KP Information Commission (Annex-B).

2. The Commission issued necessary directions to the Public Body, to share complete requested information, however, the District Accounts Office District Lakki Marwat vide letter No. DAO/LMT/ADMN/2023-24/546, dated; 27.11.2023, conveyed that the matter falls under the purview of the Additional Deputy Commissioner (Finance & Planning) Lakki Marwat and not the District Accounts Office (Annex-C).

3. In pursuance of the aforementioned letter the Commission issued necessary directions from time to time including final notice dated; 09.05.2024 to the ADC (F&P) Lakki Marwat, to share the requisite information, however, upto no avail, which warranted hearing under Section 26 of the Act (Annex-D).

4. Thus, the PIO through the ADC (F&P) was summoned to appear before the Commission on 08.01.2025 at 11:00 hours, along with complete and requisite record, to explain the reason for delay so as to decide the instant complaint on merit.

5. Incompliance, Mr. Muhammad Sajjad, Public Information Officer (PIO) DC Office Lakki Marwat appeared before the Commission and produced the requisite documents. The Commission after discussion with PIO and examining the provided documents found the requisite documents complete. It was also observed that the subject documents are covered under the purview of proactive disclosure provided under Section 5 of the Act.

**DECISION:**

Having heard the PIO and examination of record provided by the PIO, the Commission decided to forward the requisite documents to the complainant. The Commission further directed the PIO to discuss and ensure taking necessary steps for development of DC Office website as most of the Information of the DC Office is covered under the purview of proactive disclosure. The ADC (F&P) through the PIO is also directed to adhere to the directions of the Commission in letter and spirit and entertain the requests of the citizens in timely and prescribed manner as provided Act *ibid*.

With the above decision, the subject complaint was decided as disposed of.

5. Both the complaints i.e. 8885 & 10375 were discussed in detail. After having discussion with the representative of the Public Body, it was observed that the provision of record was delayed without any cogent reasons. The Registrar, assured the provision of record forthwith and as per time line given by the Commission.

**DECISION:**

Having heard the Registrar of the Public Body and complainant, the Commission directed the Registrar, being custodian of the record of the University, to ensure the provision of record to the complainant within seven (7) working days under intimation to the Information Commission.

The Registrar was further directed to ensure the uploading of information over the website of Public Body as required under Section 5 of the Act.

The Commission further advised the Registrar to direct the PIO to adhere to the directions of the Commission in letter and spirit and entertain the requests of the citizens in prescribed manner as provided in the Act ibid.

- 2 The Commission issued necessary directions from time to time, to the Public Body, to share complete requisite information, but to no avail, which warranted hearing under Section 26 of the Act *ibid*. (Annex-C).
- 3 Thus, Assistant Director Coordination/PIO of the Public Body was summoned to appear before the Commission on 16-01-2025 at 11:00hours, along with complete and requisite record, so as to decide the instant complaint on merit without further delay.
- 4 Incompliance, the Assistant Director Coordination/PIO attended the Commission on January 16<sup>th</sup>, 2025 and appraised the commission, the PIO was new one and was not well versed on the facts of the complaint.

**DECISION:**

- i. In view of the above facts; the Commission once again decided to direct the Administrative Secretary of the Department i.e Secretary ST & IT since it is mandatory on the officer to submit the asset declaration form with Administrative Department, better would be to share the same with the Commission within seven working days for examination and decision.
- ii. In case of failure to comply, the Commission will left with no choice but to take action against those obstructing the provision of information to the Commission.
