**PROCEEDINGS**

**(12th March, 2025)**

- A citizen namely Mr. Moin Ud Din Humayun has filed an information request with Law, Parliamentary Affairs & Human Rights Department, Peshawar (herein after referred) as Public Body on 22-01-2025, which was required to be entertained as per Section 10 read with Section 11 of KP RTI Act, 2013. However, the request was not entertained in the prescribed manner therefore, he has lodged a complaint before the KP Information Commission (Annex-B).
- 2 The Commission issued necessary directions from time to time, to the Public Body, to share complete requisite information, but to no avail, which warranted hearing under Section 26 of the Act *ibid*. (Annex-C).
  - 3 Thus, PIO of the Public Body was summoned to appear before the Commission on 27th February, 2025 to decide the instant complaint on merit without further delay.
  - 4 In compliance, the SOG Law /PIO of the Public Body attended the Commission appraised the Commission that an opinion has been sought from the Commission about the provision of information.
  - 5 The Commission observed that once a complaint is entertained the opinion becomes redundant.
  - 6 The PIO then informed the Commission that only one summary regarding the subject complaint has been processed by their Public Body which will be shared with the Commission within five working days positively.
  - 7 In Compliance, the PIO submitted the Summary concerned to the Commission Vide letter No.SO(G)LD/3-14(2)/2022/Vol-II/3939-40 dated 05-03-2025.

**DECISION:**

- i. In view of the above facts and after examination of the summary concerned vis a vis the provisions of the Act *ibid*; it was decided by the Commission to share the same with the complainant and dispose of the subject complaint.
