**Show Cause Notice**

**16th April, 2025**

In pursuance of the provision contained in Section 7 of the Khyber Pakhtunkhwa Right to Information Act, 2013, **Mr. Saleem Khan**, filed an information request with the Public Information Officer (PIO), Communication & Works Department (C&W), Swabi (**hereinafter referred as Public Body**) for the provision of information/record.

2. Whereas, you Engr. Shah Fahad (Sub Divisional Officer) Communication & Works Department (C&W), Swabi was required to entertain the request as per Section 10 read with Section 11 of the Act, however the Sub Divisional Officer C&W, Swabi failed to provide the requested information within prescribed time limit.

3. Whereas, feeling aggrieved, the citizen filed a complaint before the Information Commission under Section 23 (1) of the Act against you regarding non-provision of requested information.

4. Whereas the Commission issued necessary directions vide letter No. **KPIC/DR/1-11766/24/30570-72**, dated: **29<sup>th</sup> Oct, 2024**, followed by letter No. **KPIC/DR/1-11766/24/32764-68**, dated: **01<sup>st</sup> Jan, 2025** wherein the PIO was directed to provide the requisite information/record to the complainant. Moreover, the SDO committed in Summon to provide the requisite information but failed to comply.

5. Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26(3) (a & b) and 28 (1)(a) decided to serve you a show cause notice as to why punitive proceedings should not be initiated against you under Sections ibid of the Act for willful obstruction of the record and failure to comply with directions of the Information Commission issued.

6. Your reply along with complete and requisite information/record (duly verified) should reach the Commission within **seven** (07) working days of issuance of the instant show cause notice. In case of failure to comply it shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act ibid.

7. You may also attend the Commission along with the requisite information if you have any reason to defend your case.



4. Whereas you, Mr. Amir Ullah, Assistant District Education Officer (ADEO) being PIO attended the Commission.
5. Whereas, all the complaints were discussed one by one in the presence of complainants.
6. Whereas, the Commission observed that you being PIO attended the Commission without preparation and without any requisite documents in any of the complaints.
7. Whereas, the Commission directed you to appear for hearing on 25-04-2025 at Police Line, Abbottabad along with all relevant record pertaining to the subject complaints.
8. Whereas, you arrived at the Police Line, wherein, routine hearing were under process.
9. Whereas, you time and again forced the Commission staff to call you for out of turn hearing, however, you were advised to stay and wait for your turn.
10. Whereas, you left the premises without attending the Commission hearing and without intimation.
11. Whereas, the Commission seriously observed this attitude being violation of the Act and misconduct on your part.

13. Your reply to the Showcause notice along with complete and requisite information/record (duly verified) should reach the Commission within seven (07) working days, of issuance of the instant Showcase Notice.
14. In case of failure to comply, it shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act *ibid*.
