PESHAWAR**

**ORDER**

(19<sup>th</sup> August, 2025)

A citizen namely Mr. Arbab Wali Khan has filed an information request with Health Department, Peshawar (hereinafter referred as Public Body) on 09-04-2025, which was required to be entertained as per Section 10 read with Section 11 of KP RTI Act, 2013. However, the request was not entertained in the prescribed manner. Therefore, he has lodged a complaint before the KP Information Commission (Annex-B).

- 2 The Commission issued necessary directions from time to time, to the Public Body, to share complete requisite information, but to no avail, which warranted hearing under Section 26 of the Act *ibid*. (Annex-C).
- 3 Thus, PIO of the Public Body was summoned to appear before the Commission on 19<sup>th</sup> June, 2025 to decide the instant complaint on merit without further delay.
- 4 Incompliance, Section Officer /PIO of Health Department, Peshawar and Manager Legal/PIO, Khyber Teaching Hospital, Peshawar attended the Commission and undertook to provide the inquiry report to the Commission.
- 5 Incompliance the PIO of Khyber Teaching Hospital, Peshawar provided the requisite inquiry report to the Commission vide letter No. 1119/Lit/KTH dated: 13-08-2025.

**DECISION:**

- i. Having heard the Public Body and after the examination of the inquiry report, the Commission decided to transmit the same to the complainant and disposed of the subject complaint accordingly.
