In pursuance of the provision contained in Section 7 of the Khyber Pakhtunkhwa Right to Information Act, 2013, **Mr. Saleem Khan**, filed an information request with the Public Information Officer (PIO), Communication & Works Department (C&W), Swabi (hereinafter referred as Public Body) for the provision of information/record.

2. Whereas, you Engr. Shah Fahad (Sub Divisional Officer) Communication & Works Department (C&W), Swabi was required to entertain the request as per Section 10 read with Section 11 of the Act, however the Sub Divisional Officer C&W, Swabi failed to provide the requested information within prescribed time limit.

3. Whereas, feeling aggrieved, the citizen filed a complaint before the Information Commission under Section 23 (1) of the Act against you regarding non-provision of requested information.

4. Whereas the Commission issued necessary directions vide letter No. **KPIC/DR/1-11766/24/30570-72**, dated: **29th Oct, 2024**, followed by letter No. **KPIC/DR/1-11766/24/32764-68**, dated: **01st Jan, 2025** wherein the PIO was directed to provide the requisite information/record to the complainant. Moreover, the SDO committed in Summon to provide the requisite information but failed to comply.

5. Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26(3) (a & b) and 28 (1)(a) decided to serve you a show cause notice as to why punitive proceedings should not be initiated against you under Sections ibid of the Act for willful obstruction of the record and failure to comply with directions of the Information Commission issued.

6. Your reply along with complete and requisite information/record (duly verified) should reach the Commission within **seven** (07) working days of issuance of the instant show cause notice. In case of failure to comply it shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act ibid.

7. You may also attend the Commission along with the requisite information if you have any reason to defend your case.

In pursuance of the provision contained in Section 7 of the Khyber Pakhtunkhwa Right to Information Act, 2013, **Mr. FURQAN ULLAH**, filed an information request with the Public Information Officer (PIO), District Police office, Tank (hereinafter referred as Public Body) for the provision of information/record.

2. Whereas, the District Police Officer was required to entertain the request as per Section 10 read with Section 11 of the Act, however the District Police Officer failed to provide the requested information within prescribed time limit.

3. Whereas, feeling aggrieved, the citizen filed a complaint before the Information Commission under Section 23 (1) of the Act against you regarding non-provision of requested information.

4. Whereas the Commission issued necessary directions vide Letter No. **KPIC/DR/1-12019/24/32880-83**, dated: **03/1/2025**, followed by reminder letter No. **KPIC/DR/1-12019/24/34648-51** dated: **13-02-2025**, wherein the PIO was directed to provide the requisite information/record to the complainant. Moreover, DPO concerned also failed to comply the Summon Notice issued vide this office letter No. **KPIC/DR/1-12019/21/36613-17** Dated: **09-04-2025**.

5. Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26(3) (a & b) and 28 (1)(a) decided to serve you a show cause notice as to why punitive proceedings should not be initiated against you under Sections ibid of the Act for willful obstruction of the record and failure to comply with directions of the Information Commission issued.

6. Your reply along with complete and requisite information/record (duly verified) should reach the Commission within **seven** (07) working days of issuance of the instant show cause notice. In case of failure to comply it shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act ibid.

SHOW CAUSE NOTICE

(30th April, 2025)

In pursuance of the provision contained in Section 7 of the Khyber Pakhtunkhwa Right to Information Act, 2013, **Mr. Bilal Khan**, filed an information request with the Public Information Officer (PIO), Labour Department, Peshawar (hereinafter referred as **Public Body**) for the provision of information/record.

- 2 Whereas, you Mr. Khalid Hameed (Section Officer General/ PIO) Labour Department, Peshawar was required to entertain the request as per Section 10 read with Section 11 of the Act, however the Section Officer General/ PIO failed to provide complete and relevant information within prescribed time limit.
- 3 A series of correspondence were made between the PIO/ Public Body and the Commission but to no avail.
- 4 Thus, the PIO of the Public Body was summoned to appear before the Commission on 16th April, 2025 to decide the instant complaint on merit without further delay, which was attended by the representative of the Public Body namely Mr. Zahid Khan (Assistant), to whom the Commission directed to convey to the PIO of the Public Body to ensure the provision of information regarding paras 2, 3 & 4 of the RTI request of the complainant to the Commission on or before 30th April, 2025.
- 5 In case of failure the PIO may attend in person.
- 6 In continuation of proceedings dated 16th April, 2025, the representative of the Public Body/ Official namely Mr. Zahid Khan (Assistant) attended the Commission rather than the PIO of the Public Body and did not submit the requisite information.
- 7 Moreover, the representative of the Public Body stated that the PIO is busy in the budget seminar which shows lack of interest in the provision of information and contemptuous attitude of the PIO towards the Commission by avoiding and non-appearing before the Commission and submitting the requisite information by constantly using delaying tactics and taking unnecessary legal opinions from the law department.
- 8 The Commission took a serious notice of the above situation and informed the representative of the Public Body that an officer not below the rank of BPS-17 shall appear before the Commission in prospective cases.
- 9 Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26(3) (a & b) and 28 (1) (a) decided to serve you a show cause notice as to why punitive proceedings should not be initiated against you under Sections ibid of the Act for willful obstruction of the record and failure to comply with directions of the Information Commission issued.
- 10 Your reply along with complete and requisite information/record (duly verified) should reach the Commission within **five (05)** working days of issuance of the instant show cause notice. In case of failure to comply it shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act ibid.
- 11 You may also attend the Commission along with the requisite information if you have any reason to defend your case.

5. Consequently; the Commission issued Summon notices to the PIO dated: 30th July, 2025 for hearing to attend the Commission on 5th August, 2025 to explain the factual positions of the complaints along with the requisite information.

6. Moreover; as per procedure and in order to further keep close liaison with the Public Bodies; the Commission first coordinates with the PIO office for mandatory presence of the summon on the dated fixed for hearing and the same was also done in the subject complaints as well. However; when Mr. Asghar Khan Afridi contacted he denied being the PIO anymore. Then the Commission coordinated multiple section of the Public Body; but in vain. It is also pertinent to mentioned here that an official namely Mr. Naeem attended the call and was shifting the responsibility from one office to another within the Public Body.

Suffice to add that the summon letter was dispatched to Public Body though special messenger (Dispatch Rider).

Despite all these cordial formalities; there was no one to attended the summon on behalf of the Public body.

In view of the facts narrated above and such lethargic attitude on the part of the Public Body; the responsibility shifts to Director General being the Head of Directorate that why not penal action be initiated against him.

7. Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26(3) (a & b) and 28 (1)(a) decided to serve a show cause notice Director General as to why punitive proceedings should not be initiated against you under Sections ibid of the Act for willful obstructions of the record and failure to comply with directions of the Information Commission issued from time to time.

8. Your reply along with complete and requisite information/record (duly verified) should reach to the Commission within seven (07) working days of issuance of the instant showcase notice, failure to comply shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act ibid.

9. You may also attend the Commission along with the requisite information if you have any reason to defend your case.

SHOWCAUSE NOTICE

(02nd October, 2025)

In pursuance of the provision contained in Section 07 of the Khyber Pakhtunkhwa Right to Information Act, 2013, Mr. Haroon Siraj has filed an information request with University of Swat (hereinafter referred as Public Body) which was required to be entertained as per Section 10 read with Section 11 of KP RTI Act, 2013 However, the request was not entertained in the prescribed manner, therefore, he lodged complaint before the KP Information Commission.

2. Whereas, the Commission issued necessary directions to share the requisite information with the complainant, however, the Public Body failed to provide the requisite information, therefore, the Commission decided to summon the Public Body.
3. Whereas, the Vice Chancellor/Public Information Officer, University of Swat was summoned to appear before the Commission on 08.07.2025 along with complete and requisite record, so as to decide the instant complaints on merit without further delay.
4. Whereas, the Registrar, University of Swat through email dated: 30.06.2025 requested for an extension of time i.e. one month for proper collection and submission of requisite record to the Information Commission.
5. However, the information/record were not provided even after extended period of one month time. Hence, the Registrar was again directed vide letter dated: 12.08.2025 to provide the requisite information within seven days positively but to no avail.
6. Whereas, you, the Registrar, University of Swat being custodian of record was once again summoned to appear before the Commission for hearing on 25.09.2025 along with complete and requisite record, but once again failed to attend the proceedings nor provided the requisite information/record.
7. Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26 read with section 28 of the Act *ibid* decided to serve you the instant Show Cause Notice as to why punitive proceedings should not be initiated against you i.e. Registrar, University of Swat under sections *ibid* of the Act for willful obstruction of the official record and failure to comply the lawful directions of the Information Commission.
8. Your reply to the Showcause notice along with complete and requisite information/record (duly verified) should reach the Commission within seven (07) working days, of issuance of the instant Showcase Notice.

9. In case of failure to comply, it shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act *ibid*.

10. You may also attend the Commission along with the requisite information if you have any reason to defend your case.

In pursuance of the provision contained in Section 7 of the Khyber Pakhtunkhwa Right to Information Act, 2013, **Mr. Muhammad Tariq Anwar**, filed an information request with the Secretary, Khyber Pakhtunkhwa, Trade Testing Board, Peshawar (hereinafter referred as Public Body) for the provision of information/record, on 20-03-2025.

2. Whereas, the PIO was required to entertain the request as per Section 10 read with Section 11 of the Act, however the Secretary/PIO failed to provide the requested information within prescribed time limit.
3. Whereas, feeling aggrieved, the citizen filed a complaint to the Information Commission, registered vide dairy No: **17284**, dated **10-04-2025** under Section 23 (1) of the Act against you regarding non-provision of requested information.
4. Whereas the Commission issued necessary directions Secretary/PIO vide letter No. **KPIC/DR/1-12351/25/37268-71**, dated: **29-04-2025**, followed by reminder No. **KPIC/DR/1-12351/25/38076-79**, dated: **22-05-2025**, and letter to Head of Department **KPIC/DR/1-12351/25/38970-74**, dated: **16-06-2025**, but to no avail.
5. Consequently; the Commission summoned the Secretary/PIO of the Public Body, vide letter No. **KPIC/DR/1-12351/25/40133-37**, dated: **08-07-2025**, for hearing on **17th July, 2025** to explain the factual position. In compliance the Secretary/PIO of the Public Body attended the Commission on date fixed for hearing and necessary directions were issued to the Secretary/PIO vide Proceedings Order No. **KPIC/DR/1-12351/25/40133-37**, dated: **25-07-2025**. In response the Secretary/PIO submitted reply to the Commission vide letter No. **TTB/Information/34841** dated: **23-07-2025**, which was forwarded to the complainant but the complainant was not satisfied with the reply of the Public Body.
6. Subsequently; the Commission once again summoned the Secretary/PIO vide letter No. **KPIC/DR/1-12351/25/43984-88**, dated: **12-09-2025** to attend the Commission for hearing on **23rd September, 2025**. The Secretary/PIO appeared before the Commission on the date fixed for hearing and necessary directions was issued to the Secretary/PIO vide Proceedings Order No. **KPIC/DR/1-12351/25/45328-34**, dated: **30/09/2025**. In compliance the Secretary/PIO submitted reply to the Commission vide letter No. **KP-TTB/information/35534** dated: **08-10-2025**. The Commission examined the reply of the Public Body and found it irrelevant. Upon which the Commission decided to Re-summon the Secretary/PIO vide letter **KPIC/DR/1-12351/25/40133-37**, dated: **22-10-2025** to attend the Commission on 28th October, 2025, but the PIO failed to attend the Commission.

Consequently; the Commission issued Summon vide proceedings Order No. KPIC/DR/1-11635/2024/46785-93 dated: 23-10-2025 to the PIO and Section Officer (Arms) for hearing to attend the Commission on 28th October, 2025 to explain the factual positions of the complaints along with the requisite information.
7. In compliance Mr. Haleem Shah, Deputy Director (SAW)/PIO attended the Commission and the Section Officer (Arms) absented himself from the hearing of the Commission on the date fixed for hearing.

10. You may also attend the Commission along with the requisite information if you have any reason to defend your case.


