**ORDER**

Facts of the complaints are that the Commission served a Show Cause notice to the Superintendent of the District Education Officer (Female), Peshawar vide No. RTIC/AR/1-9800/2022/49004-13 dated: 01-12-2025.

2. In compliance the Superintendent, District Education Officer (Female), Peshawar submitted reply of the Show Cause issued along with the requisite information, to the Commission vide letter No. 2464/Suptd File dated: 11-12-2025.

**REF: DR. KHALID KHAN VS DIRECTORATE GENERAL OF SCIENCE &  
TECHNOLOGY, PESHAWAR.**

**ORDER**

**(28<sup>th</sup> January, 2026)**

- A citizen namely Dr. Khalid Khan has filed information request with Science Technology & Information Technology Department, Peshawar (hereinafter referred as Public Body) on 28-11-2022, which was required to be entertained as per Section 10 read with Section 11 of KP RTI Act, 2013. However, the request was not entertained in the prescribed manner. Therefore, he has lodged a complaint before the Khyber Pakhtunkhwa Information Commission
- 2 The Commission issued necessary directions from time to time, to the Public Body, to share complete requisite information, but to no avail, consequently the Commission issued show cause notice to the Director General for continues delinquency in the provision of information.
  - 3 Accordingly personal hearing opportunity was afforded to the Director General of Directorate General Science & Technology, Peshawar as last resort, on 21<sup>st</sup> January, 2026.
  - 4 The Director General did not appear before the Commission on the date fixed for hearing
  - 5 However; Incompliance; the Public Body submitted reply to the Commission vide letter No. **DGS&T/KP/RTI/Vol-III/2026** dated: **15-01-2026** received on dated: 19-01-2026. Wherein it is request that the Director General is presently undergoing mandatory training for promotion commenced on 05<sup>th</sup> January, 2026 and will continued for a period of **10** weeks and the matter may kindly be adjourned to a later date after completion of the training.
  - 6 In view of the above and after examination of the reply produced by the Public Body the Commission decided to accept the request of the Public Body and extended the timeline for response upto the completion of the training.
  - 7 The Commission further decided to not withdraw the Show Cause notice served upon the Director General, Directorate General Science & Technology, Peshawar unless the Director General in person regarding the subject complaint or submit a satisfactory reply to the Show Cause notice to the Commission till the above referred timeline.
  - 8 In case of failure to comply with the directions of the Commission, the Commission would be proceed for penal action under Section 26 read with Section 28 of the KP RTI Act 2013.



**BRIEF FACTS OF THE COMPLAINT:-**

- A citizen namely Mr. Said Ali Khan has filed information request with Local Council Board, Peshawar (hereinafter referred as Public Body) on 22-10-2021, which was required to be entertained as per Section 10 read with Section 11 of KP RTI Act, 2013. However, the request was not entertained in the prescribed manner. Therefore, he has lodged a complaint before the Khyber Pakhtunkhwa Information Commission.
- 2 The Commission issued necessary directions from time to time, to the Public Body, to share complete requisite information, but to no avail, which warranted hearing under Section 26 of the Act *ibid*.
  - 3 Thus, PIO of the Public Body was summoned to appear before the Commission on 20<sup>th</sup> January, 2026 to decide the instant complaint on merit without further delay.
  - 4 No one attended the Commission on part of the Public Body on the date fixed for hearing.
  - 5 However; Incompliance Deputy Director (HQ) of the Public Body submitted the requisite information to the Commission vide letter No. **DL&DD/MDs/(E)/41** received vide dairy No. **21938** dated: **28-01-2026**.

**DECISION:**

- i. In view of the above and after examination of the information produced the Commission decided to transmit the information so received from the Public Body to the complainant with the direction to confirm the receipt of information complete and relevant within **seven** working days positively rather than issuance of Show Cause notice to the Public Body.
- ii. In case we do not receive any response from you, the instant complaint will be stands disposed of.
