**Show Cause Notice**  
**(07<sup>th</sup> January, 2026)**

In pursuance of the provision contained in Section 7 of the Khyber Pakhtunkhwa Right to Information Act, 2013, Mr. Saad Ahmad, filed an information request with the Administrator/PIO, Auqaf, Hajj, Religious & Minority Affairs Department, Peshawar (hereinafter referred as Public Body), for the provision of information/record, on 25-09-2025.

2. Whereas, the PIO was required to entertain the request as per Section 10 read with Section 11 of the Act, however the PIO failed to provide the requested information within prescribed time limit.

3. Whereas, feeling aggrieved, the citizen filed a complainant before the Information Commission, registered vide dairy No: 20606, dated 29/10/2025 under Section 23 (1) of the Act against you regarding non-provision of requested information.

4. Consequently; the Commission issued summoned to the Administrator/PIO of the Public body vide letter No. KPIC/DR/1-13137/25/50698-702 dated: 30-12-2025 for 07<sup>th</sup> January, 2026, but the Administrator/PIO did not appear before the Commission on the date fixed for hearing.

5. Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26(3) (a & b) and 28 (1)(a) decided to serve you (Administrator/PO) a show cause notice as to why punitive proceedings should not be initiated against you under Sections ibid of the Act for willful obstructions of the record and failure to comply with directions of the Information Commission issued from time.

6. Your reply along with complete and requisite information/record (duly verified) should reach to the Commission within seven (07) working days of issuance of the instant showcase notice, failure to comply shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act ibid.

7. You may also attend the Commission along with the requisite information if you have any reason to defend your case.

**Show Cause Notice**  
**(07<sup>th</sup> January, 2026)**

In pursuance of the provision contained in Section 7 of the Khyber Pakhtunkhwa Right to Information Act, 2013, **Mr. Faiq Zaman**, filed an information request with the Tehsil Municipal Officer/PIO, Tehsil Municipal Administration, Rustam, Mardan (hereinafter referred as Public Body), for the provision of information/record, on 26-12-2024.

2. Whereas, the PIO was required to entertain the request as per Section 10 read with Section 11 of the Act, however the PIO failed to provide the requested information within prescribed time limit.

3. Whereas, feeling aggrieved, the citizen filed a complainant before the Information Commission, registered vide dairy No: **19807**, dated **11/09/2025** under Section 23 (1) of the Act against you regarding non-provision of requested information.

4. Whereas the Commission issued necessary directions vide letter No. **KPIC/DR/1-12976/24/45155-59**, dated: **29-09-2025**, followed by Final Notice No. **KPIC/DR/1-12976/24/49391-95**, dated: **03-12-2025**, wherein the PIO was directed to provide the requisite information/record to the complainant, but the PIO submitted a misleading reply vide letter No. **7504-7509/TMA/R** dated: **11-12-2025**

5. Consequently; the Commission issued summoned to the PIO of the Public body vide letter No. **KPIC/DR/1-12976/25/50703-07** dated: **30-12-2025** for 07<sup>th</sup> January, 2026, but the PIO did not appear before the Commission on the date fixed for hearing but to no avail and send the above referred reply again to the Commission vide letter No. **7551-56/TMA/R** dated: **06-01-2026** received on date: **08-01-2026**.

6. Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26(3) (a & b) and 28 (1)(a) decided to serve you (Tehsil Municipal Officer) a show cause notice as to why punitive proceedings should not be initiated against you under Sections ibid of the Act for willful obstructions of the record and failure to comply with directions of the Information Commission issued from time.

7. Your reply along with complete and requisite information/record (duly verified) should reach to the Commission within **seven** (07) working days of issuance of the instant showcase notice, failure to comply shall be presumed that you have no cause to defend yourself and the matter will be decided in light of Section 26 (3)(b) read with Section 28 of the Act ibid.

8. You may also attend the Commission along with the requisite information if you have any reason to defend your case.

5. Consequently; the Commission issued summoned to the PIO of the Public body vide letter No. **KPIC/DR/1-13222/25/51403-07** dated: **13-01-2026** for 21<sup>st</sup> January, 2026, but the PIO did not appear before the Commission on the date fixed for hearing.
6. Keeping in view the above facts, the Commission, in exercise of the powers conferred under section 26(3) (a & b) and 28 (1)(a) decided to serve you (District Education Officer (Male)/PIO) a show cause notice as to why punitive proceedings should not be initiated against you under Sections ibid of the Act for willful obstructions of the record and failure to comply with directions of the Information Commission issued from time.
